AUGUST DEBOUZY ADVISES LUCIA HOLDING IN CONNECTION WITH THE ACQUISITION OF A MAJORITY STAKE IN ENERGIES LIBRES WITH PRIMÉO ENERGIE AG

August Debouzy advised Lucia Holding, a renewable energy producer, in connection with its acquisition of a majority stake in Energies Libres, with Priméo Energie AG.

This partnership will be established through the creation of a joint venture, Priméo Energie France, 65% owned by the Swiss group and 35% by Lucia Holding. This alliance will form a new independent electricity and gas supply group, supported by renewable energy producers.

The combination of Energies Libres, Energies Libres Grands Comptes and Priméo Energie AG will provide the French market with technical and commercial expertise with more than 50 TWh sold, which will be made available to key accounts, local administration authorities, SMEs and private customers.
