After graduating from *ENA*, Emmanuelle Mignon joined the *Conseil d'Etat* where she successively held the positions of *rapporteur* (junior judge) in the Rules of Procedure Division, head of the documentation center and *commissaire du gouvernement* (independent judge who renders impartial opinions on cases before the *Conseil d'Etat*). In 2002, she was appointed advisor to the office of the Minister of the Interior, Nicolas Sarkozy, whom she followed when he became Minister of Economy and Finance, then during his presidential campaign in 2007, and then as president (2007-2009).
